



## RULES AND REGULATIONS Ballot Contest

### **1. HOW TO ENTER**

Entry forms are available on our “Free Cover Pass” and from our Promotion team members or at the cover booth. No duplicate, faxed, mailed or reproduced ballots will be accepted. Only one ballot per media source per person will be accepted.

No purchase necessary. Participants must complete a ballot by providing their name, Email address, age\*, postal code\* and telephone number(s), and deposit the entry form in the ballot box located at 172 Simcoe Ave. Ptbo. All entries that are incomplete, illegible, damaged, delayed or do not conform to or satisfy any condition of these rules may be disqualified.

### **2. PRIZES**

The duration of the ballot contest will run from Tuesday, October 13<sup>th</sup>, 2009 to Tuesday, November 3<sup>th</sup>, 2009. There will be One Prize awarded, on Oct 13<sup>th</sup>, Oct 20<sup>th</sup>, Oct 27<sup>th</sup>, and November 3<sup>rd</sup>

### **3. CONTEST CLOSING AND ELIGIBILITY**

To be eligible for the first ballot draw, all entries must be received by Tuesday, October 13<sup>th</sup> at 1:15a.m.

To be eligible for the second ballot draw, all entries must be received by Tuesday, October 20<sup>th</sup> at 1:15 am

To be eligible for the Third ballot draw, all entries must be received by Tuesday, October 27<sup>th</sup> at 1:15 am

To be eligible for the Fourth ballot draw, all entries must be received by Tuesday November 3<sup>rd</sup> at 1:15 am

All winners must be 19 years of age or older.

The contest is open to all Canadian citizens and landed immigrants who are residents of Canada, but excluding retail employees of The Kawartha Entertainment Group, Opertitel, promotion agencies, personal associates, families, as well as those with whom they reside (collectively the “Sponsors”). No prize will be awarded to a Sponsor.

#### **4. SELECTION OF WINNERS**

The prize entries for the first ballot contest will be randomly drawn on or after Oct 13<sup>th</sup>, 2009, and the prize entries from the second ballot contest will be randomly drawn on or after October 20<sup>th</sup>, 2009, from all eligible entries received. Potential winners will be contacted by telephone. If they cannot be reached by telephone, an Email letter will be sent. Potential winners will have 5 days from the date of mailing to respond; otherwise, another eligible entry will be drawn.

The odds of winning will depend on the total number of eligible entries received.

In order to be declared a winner, a potential winner will be required to complete, sign and return a Declaration and Release Form provided by the Sponsors within 7 days of notification, and must have abided by the rules and regulations of this contest. Failure to return the duly completed Declaration and Release Form within the time stipulated will result in disqualification and another entry will be randomly selected from the remaining eligible entries. Potential winners are also required to answer correctly a four part mathematical skill-testing question on the Declaration and Release Form in order to claim their prize; otherwise another eligible entry will be drawn.
